

I am currently serving as the Building and Plans Review Manager for the City of Knoxville. This is a new position within the Plans Review and Inspections department, designed to expand and enhance the plans review process and accommodate increasing growth and development in the city of Knoxville. Prior to joining the City of Knoxville inspections team in 2018, I spent approximately 15 years in the private sector, working in architectural design, project management, and commercial real estate development and management.

ABOUT THIS COURSE

The City of Knoxville Plans Review and Inspections team will cover Construction Testing & Special Inspections requirements for commercial projects within their jurisdiction. The presentation will also touch on frequent code oversights and recent updates to the submission process, including naming conventions, Citizen Access Accounts, and plans review / how to streamline the process.

HSW JUSTIFICATION

Understanding Construction Testing & Special Inspections requirements is crucial for architects and builders to ensure that construction projects meet safety standards. These inspections help identify potential structural issues, ensuring the stability and integrity of buildings, ultimately safeguarding the Health, Safety, and Welfare of the public who will inhabit or interact with the structures. Compliance with these requirements also minimizes risks associated with substandard construction practices, contributing to overall community well-being.

LEARNING OBJECTIVES

- 1. Upon completion of this course, participants will be able to proficiently interpret and apply Construction Testing and Special Inspections Requirements, demonstrating a comprehensive understanding of the procedures, standards, and documentation necessary to ensure compliance and the structure integrity of construction projects.
- 2. Participants will understand the importance of coordinating special inspections of deferred submittal items with the design professional, contractor, and local jurisdiction.
- 3. Participants will be equipped to identify and rectify common building code oversights in construction projects, including the ability to navigate regulatory frameworks, ensuring compliance, and minimizing the risk of errors or omissions in building design and implementation.
- 4. The presentation will conclude with a discussion of the adoption, by the City of Knoxville, of the 2024 I-Codes in January of 2025, and how this code adoption relates to Special Inspections and common building code oversights.


