What I learned in CSI


When I was a young teen, I helped my Dad renovate old houses on weekends for a real estate agent. Dad always said that proper preparation was the key to a good paint job. Dad also said not to "paint the paint" or to keep the brush/roller with enough paint to cover the surface.

What does this have to do with CSI? Recently, my Homeowners Association (HOA) needed to repaint the aluminum street sign posts in our neighborhood. The aluminum posts were slightly damaged with lawn trimming equipment, corroded from road salt, and the existing black paint had turned "chalky". I knew that the CSI paint product representatives would have some good recommendations. I called my good friends Kent Kile with PPG and Dwight LeClair with Sherwin Williams who had good recommendations. They recommended wire brushing the street signs, followed by a good cleaning. Next was a high quality primer intended for exterior aluminum signs and then the final flat black paint application. All of this information was shared with my HOA friends. I personally did the work on two of the four signs. A wire brush chucked into my cordless drill did the recommended wire brushing work in a short amount of time. The wire brush work was followed with some biodegradable cleaner and I also rinsed the sign post surface well with water. Kent and Dwight had both said that the primer and final paint could be applied with a small roller, but I elected to use an old fashioned good quality paint brush due to the ridge and valley texture of the sign posts. My Dad's advice about painting was in my mind as I was doing this work in the warm July sun. The surface was prepared well, the proper primer was used, and the final paint coat was going on smoothly. Attached are some before and after photos of the sign posts. When we observed the work performed on the other signposts, they did not look as good. Apparently, the posts were cleaned, but not wire brushed. The sage advice from Kent and

Dwight were not followed. The original paint had started to flake off where the sign post had been damaged with lawn trimmers. Since the posts were not wire brushed, the new paint did not adhere well to the old paint. There were areas on the post where the new paint was already failing. If it was not for my Dad's advice and the CSI paint product representative friends, the sign posts would not have resulted in such a good looking final product. The "moral of the story" is to come to the next CSI meeting for great fellowship, life-long friends and good advice for your personal and professional life.

CSI November Presentation

Quality Control and Quality Assurance: How Much Quality is Too Much Quality?



Presented by:

Randy Martin, P.E., is the Director of Construction Services and Vice President with S&ME, Inc., an engineering design and consulting firm with approximately 1,000 employees located in Tennessee, Ohio, Kentucky, Alabama, Georgia, Florida, Pennsylvania, and the Carolinas. Here in Tennessee, S&ME has offices in Knoxville, Tri-Cities, Chattanooga, and Nashville.

Mr. Martin is in his 22nd year with S&ME, having served as a branch manager at 3 branch locations, and was the Independent Construction Quality Manager for a \$440 million design-building interstate project in Utah. He currently serves as a co-chair to the Construction Materials Engineering and Testing Business Council of the Geo-professional Business Association (formerly known as ASFE).

Mr. Martin will present on the very important, but often misunderstood, topic of Quality Control (QC) and Quality Assurance (QA), as it relates to different types of construction. While not all construction projects require a comprehensive QA/QC plan, the proper implementation of either (or both) can save owners significant amounts of money and help maintain construction schedules. The balance (in developing such a QA/QC plan) is to provide sufficient testing and observations to satisfy the owner, contractor, design team, and when required, local building officials, without redundancy in services or needless testing and observations.

As an example, how much “oversight” is necessary during concrete placement of foundations for a residential garage? Similarly, how much is needed for pouring a 4 feet thick containment wall for the reactor vessels at a nuclear power plant? While you would expect these two scenarios require significantly different levels of QA/QC, you may be surprised how proportionally similar the two may be. This presentation may not solve all of construction’s challenges with understanding QA/QC; however, it might shed some light on how to proportionally implement both on almost every project.

CELEBRATE THE FELLOWS!

Conventions are like state or county fairs: it seems they're the same year after year, and yet, if you compare this year's to the one a few years ago, there will be small differences. But sometimes, significant changes take place between one fair and the next.



Until this year, the social highlight of the annual convention was the President's Gala. A black tie dinner, with all that entails - including formal dresses and tuxedos - along with meeting the new president and witnessing the investiture of Fellows, was the grand finale. This year we tried something different. The events of the Gala were

separated, some being added to other events, some becoming new events. Instead of being among the last events, the investiture of Fellows was moved to Tuesday evening, and the introduction of Distinguished Members was moved to the opening general session Wednesday morning.

When the new format was presented to the College of Fellows board of directors last January, it sounded good. We knew a lot of members saw the Gala as the high point of the convention, but the cost made it difficult for many members to attend this great event. This year, part of the plan was to make the presentations of various awards more visible and more accessible to more members. The investiture of Fellows would be open to all, at no charge; the Celebration of Fellows, a social event following the investiture, would cost only \$35; and many awards would be presented at the annual meeting.

As the months went by, I began to have some reservations. The convention schedule, which is so tight it always irritates someone, put the investiture up against the welcome reception, and I feared it would be hard to pry people away from the party. The location of the Celebration presented two potential problems: attendees had to submit their names ahead of time for a background check, and it was in a different building.

As it turned out, the new format was a great success. The scheduling of the investiture and the introduction of Distinguished Members made those events more accessible and more affordable than before. Even though the investiture began before the welcome reception was over, registered attendance was 227, and more than that attended. Attendance at the annual meeting was 291, and I suspect there were three hundred or more people at the opening session. Not only was the attendance good, but making these two of the first events gave members the rest of the week to congratulate the honorees.

The weather was good, so the short walk from the welcome reception to the Celebration of Fellows, at the top of the Baltimore World Trade Center, presented no problem. The walk itself became an event due to the surprise appearance of a piper who led the procession from the investiture to the Celebration of Fellows. The piper was Mike Young, former president of the Denver Chapter and part of the group that assembled Ann

The construction stage of a project is the process of executing the requirements of contract documents and thus providing the required quality. Contractor project management and construction contract administration involve the quality assurance (QA) and quality control (QC) processes.

- Quality refers to the project requirements established by the contract documents.
- QA refers to the procedures for guarding against defects and deficiencies before and during the execution of the work. It includes submittals, certifications, and other actions to assure that the proposed products and services meet the contract requirements.
- QC refers to the procedures for

evaluating completed activities and elements of the work for conformance with contract requirements. Procedures include testing and inspection. Contractual agreements may include the responsibility and authority to find and correct causes of unsatisfactory performance.


